Dear Squash Committee,

Things have moved on a bit with the insurance.

I have a verbal assurance that everything is OK for cover to be extended. Jon and I drafted a cheque and I will send this on shortly with a covering letter (attached).

It looks like we won't be able to cover under 18 year olds, so I suggest we put notices accordingly as well as saying that non-members won't be covered.

There is still an outstanding question on what membership details Perkins Slade require. This question was raised by me, the company didn't appear to have worried about this when they told me they would cover us. I thought it prudent though to check.

The only thing I anticipate is that they will insist on us maintaining a membership list. If they do, one possibility is that we ask IT to create a squash@icr.ac.uk email address and tell all players that they have to email this to be covered. This could be a 'least effort' type system that might do the job for us (electronically).
